ADVICE TO ALL LICENSEES (LICENSE HOLDERS IN TERMS OF ACT 27 OF 1989) WHO HAVE APPLIED FOR CONVERSION OF THEIR LICENSES IN TERMS OF SECTION 143 OF THE GAUTENG LIQUOR ACT 2 OF 2003.

PLEASE BE ADVISED THAT ALL LICENSE HOLDERS WHO HAVE APPLIED FOR CONVERSIONS AND WHO ARE IN POSSESSION OF A CONVERSION ACKNOWLEDGEMENT LETTER WILL NOT BE RECEIVING ANNUAL RENEWAL FORMS THIS YEAR .


THE GAUTENG LIQUOR BOARD IN TERMS OF SECTION 143 OF THE GAUTENG LIQUOR ACT 2 OF 2003 IS CURRENTLY ATTENDING TO CONVERTING ALL SECTION 143 APPLICATIONS FOR CONVERSIONS AND WILL ISSUE CONVERTED LICENSES BY NO LATER THAN THE 31ST OF DECEMBER 2010 .

APPLICANTS WILL BE CONTACTED TO COME AND COLLECT THEIR CONVERTED LICENSES.

LICENSEES (LICENSE HOLDERS IN TERMS OF ACT 27 OF 1989) WHO HAVE NOT APPLIED FOR CONVERSIONS, WILL HAVE THEIR LICENSES LAPSE ON 31ST DECEMBER 2010 AND THEY MUST RE-APPLY IN TERMS OF SECTION 23 OF THE GAUTENG LIQUOR ACT 2 OF 2003 , FOR A NEW LICENSE .

Steps which have been followed in converting liquor licenses from the National Liquor Act 27 of 1989 to the Gauteng Liquor Act 2 of 2003:

1. The Conversion process was published initially on the 09 January 2009 in the Provincial Gazette.
2. Applicants were urged to apply to have their licenses converted .
3. The process was extended (in the Provincial Gazette) 2 times ending on the 01st March 2010.
4. Applicants who applied were issued with acknowledgement letters .
5. The Gauteng Liquor Board acknowledged receipt of only 6261 applications.
6. All applications for conversion will be considered by the Gauteng Liquor Board and be converted into licenses under the Gauteng Liquor Act 2 of 2003.
7. All converted licenses will be issued by the 31st December 2010.
8. Applicants will be contacted to come and collect their converted licenses.
9. Applicants for conversions will not be issued with renewal notices
